CODE OF CONDUCT

FOR ALL VISITORS:

1. Groups of four (4) or more will be dispersed. Customers must keep moving – in an orderly fashion through the premises and not block walkways or store entrances. Congregating and loitering in such a way as to cause inconvenience to others is not allowed.
2. Seating benches are to be used for shopping breaks not to exceed 15 minutes.
3. Food Court is for paying customers of the Food Court.
4. Loud and boisterous behavior and obscene or offensive language will not be permitted.
5. No unauthorized photography or video taping is permitted.
6. Inappropriate behaviors, vandalism or any unacceptable conduct on the premises such as running, spitting, sitting in or on the planters, or throwing objects will not be permitted and will be grounds for ejection.
7. Carrying or displaying a weapon of any kind, whether or not by permit is prohibited, except those carried by certified Federal, State and Local law enforcement officers in the performance of their duties.
8. When conditions contribute to an overflow of juveniles, management reserves the right to disperse or eject individuals or groups.
9. Appropriate clothing is required at all times, which include shoes, shirts, and pants held on at the waist with no underwear or skin showing, etc. No offensive messages or pictures may be displayed on clothing. Hoods on apparel must be worn down and face-covering apparel is not permitted in the center.
10. Individuals of school age are expected to be in attendance at school during the hours their schools are in session or otherwise in transit to or from home.
11. Distribution of literature, solicitation, demonstrations, and special promotions or using the property for any purpose other than shopping is prohibited, without prior written permission of Mall Management.
12. Smoking or the use of electronic cigarettes is not permitted within the shopping center, at any mall entrance that may also include the Plaza.
13. Alcoholic beverages are not allowed except in licensed establishments.
14. Intimidation or harassment of others through the usage of obscene or offensive language or gestures is prohibited.
15. Overnight vehicle parking is prohibited.
16. Pets are not allowed. However, assistance dogs or assistance dogs in training are permitted with appropriate certification. Certificate must be presented upon request.
17. Any act which could result in substantial risk of physical harm to persons or property that may include the use of skateboards, hover boards, or other electric or battery operated amusements are prohibited.



FOR VISITORS UNDER THE AGE OF 18:

- Under the Mall at Stonecrest's Parental Involvement Program (PIP), youths must be accompanied by a parent or legal guardian aged 21 and over after 4:00 pm on Friday and Saturday. Valid proof of age will be required.
- One parent or legal guardian may escort up to four youths, and at least one of the youths must be the child of the parent or legal guardian. Parents or legal guardians are responsible for the actions of the escorted youths.
- The purchase of a movie ticket does not exempt a child from compliance with the Parental Involvement Program. Youths exiting the theater after 4:00 pm on Friday or Saturday must immediately leave the property if not escorted by a parent or legal guardian.
- When conditions contribute to an overflow of youths, management reserves the right to disperse and/or eject individuals or groups.
- School groups are welcome, but the school should register in advance with the mall management office, which can be reached at (678) 526-9880.
